Items Needed for Tax Prep

- Need a copy of all personal property tax bills
- Need a copy of 1096 filed for your 1099 contractors. You were required to file a 1099 for each personal making over \$600 for the years. The 1096 is the summary of the 1099s for IRS. (Note: If filed 1099s here we have this already)
- Need the separate breakdown sheet for Equipment, furniture, phones, and GPS units purchased in the tax year. List date, what it was, and how much.
- Special note for internet & telephone expense. We need you to tell us the total amount you paid for the entire year and then how much you used it for business. We will calculate the deductible amount from there. Example: Internet \$1523 - 40%. Then we will take $1523 \times .40 = 609.20$. The 609.20 will be the deductible amount.
